BUILDING AND SUSTAINING THE ORGANIZATION - WITH FUNDING FROM THE ALFRED P. SLOAN FOUNDATION THE DPLA WAS CREATED AND LAUNCHED TO MANAGE A NATIONAL DIGITAL LIBRARY PLATFORM FOR THE UNITED STATES OF AMERICA. THIS SUPPORT ENABLED THE NEWLY ESTABLISHED DPLA, INC., TO HIRE A FOUNDING EXECUTIVE DIRECTOR AND THE TWO INITIAL STAFF MEMBERS WHO THROUGH A PLANNING PROCESS MADE A WORK PLAN AND DEVELOPED AN INITIAL SYSTEM TO ESTABLISH THE ORGANIZATION AND BRING THE PLAN INTO FRUITION. FOLLOWING A SUCCESSFUL PLANNING PHASE AND LAUNCH IN APRIL 2013, THE DIGITAL PUBLIC LIBRARY OF AMERICA IS WELL ON ITS WAY TO ACHIEVING ITS AMBITIOUS GOAL OF BRINGING TOGETHER THE RICHES OF AMERICA'S LIBRARIES, ARCHIVES, AND MUSEUMS, AND MAKING THEM FREELY AVAILABLE TO RESEARCHERS AROUND THE WORLD. BUT IN ORDER TO FULFILL THIS MISSION, THE ORGANIZATION MUST FIND A SOUND AND SUFFICIENT MODEL FOR SUSTAINABILITY OVER THE NEXT TWO YEARS. ALTHOUGH IT HAS RECEIVED WIDESPREAD RECOGNITION AND EVEN ACCLAIM IN ITS FIRST YEAR, DPLA NEEDS TO HIGHLIGHT ITS VALUE BETTER TO POTENTIAL SUPPORTING INSTITUTIONS OR INDIVIDUALS, AND THEN ESTABLISH A MEANS FOR CONVERTING THAT INTEREST INTO REGULAR, ONGOING FUNDING. SUPPORT FROM THE ANDREW MELLON FOUNDATION WILL HELP DPLA MOVE TO SUSTAINABILITY.

DPLA DIGITAL HUBS - WITH FUNDING FROM THE NATIONAL ENDOWMENT FOR THE HUMANITIES, THE KNIGHT FOUNDATION AND THE BILL AND MELINDA GATES FOUNDATION DPLA IS ESTABLISHING A NATIONAL NETWORK OUT OF THE OVER FORTY STATE/REGIONAL DIGITAL LIBRARIES AND MYRIAD LARGE DIGITAL LIBRARIES IN THE U.S., BRINGING TOGETHER DIGITIZED AND BORN-DIGITAL CONTENT FROM ACROSS THE COUNTRY INTO A SINGLE ACCESS POINT FOR END USERS, AND AN OPEN PLATFORM FOR DEVELOPERS.
