

Terms of Service

Backed Finance AG, a company incorporated under the laws of Switzerland ("**Backed Finance**", "**us**", "**we**", or "**our**") owns and maintains this website ("**Site**"). These Terms of Service ("**Terms**") govern your access and use of the Site, including the ability to contact us regarding our business and access to informational material about xStocks, if and as available from time to time (together with the Site, the "**Services**").
